

#### 4 Gun Safety Rules:

1. The gun is always loaded unless you check it yourself.
2. Never point gun at something you're not prepared to destroy.
3. Always be sure of your target and what is behind it.
4. Keep your finger off the trigger until your sights are on the target.

#### RANGE RULES

- 1 Shooters under 18 must be with adult supervision at all times on the range. Do not allow children under 18 out of your sight.
- 2 Range fee is nonrefundable and non-transferable. If you want to return you will have to pay a lane fee again (unless you have a membership) and/or wait until there is another lane open.
- 3 All renters must be at least 21 years of age for pistol.
- 4 No FELONIES! It is illegal to be in possession of a firearm with a felony.
- 5 Eye and ear protection must be worn upon entry to the range and at all times on ranges. Even for spectators. Indoor range you must have hearing muffs. Ear plugs alone are not enough.
- 6 Eating, drinking, smoking, drug and alcohol use is prohibited on the range. **Any person who has consumed alcohol or drugs prior to shooting WILL NOT be permitted on the range.**
- 7 **The use of Marijuana (MEDICAL or recreational) is prohibited while using firearms!!!!!! Federal and state law!!!!!!**
- 8 **NO SHOTGUNS ALLOWED!!!**
- 9 **INDOOR RANGE: NO FN 5.7X28, 22 TCM, no steel cased or uncoated ammo, NO 410 shells!**
- 10 Know how your firearm(s) work and how to safely use it. Please ask our staff if you need assistance.
- 11 DO NOT load gun until at firing line and unload before leaving firing line. All guns are to be unloaded with actions open when you are not at the shooting station with muzzles pointed DOWNRANGE.
- 12 **NO DRAWING FROM HOLSTER** except to place on the shooting bench.
- 13 Firearms and ammunition are subject to inspection at any time.
- 14 Only one person may fire from each firing lane at a time. Do not switch firearms from lane to lane, move shooters not firearms.
- 15 Fire only at YOUR target do not fire across lanes. Firing at anything other than your target may result in ricochets that could seriously injure or kill you or other shooters.
- 16 Fire only from INSIDE your shooting station and over the table. Firearms should never be behind table when shooting.
- 17 DO NOT use I-Pods, phones or cameras while out on the range for safety reasons. **DO not create any type of distraction that can cause a safety issue.**
- 18 You may keep your brass that you shot that day; never cross firing line to retrieve any. **DO NOT throw brass in trash. We will clean up brass periodically.**
- 19 Do NOT clean or disassemble firearms out on the range or retail area. We are not responsible for lost parts.
- 20 If "**cease fire**" is called you are to stop shooting immediately, place firearm on bench and back away from firing line.
- 21 At no time may a firearm with a malfunction come into the store. If you need assistance come get an employee.
- 22 The Range Safety Officer and employees on duty is in direct charge of the range at all times. Range Officer commands must be followed immediately. All range officers have the right to deny range access if any of the range rules are violated resulting in an unsafe act.
- 23 All firearms and accessories must be in good working order and range reserves the right to ask customers to no longer shoot firearms that aren't working properly.
- 24 Both indoor and outdoor forbidden use of tracers, incendiary gas, steel core, or explosive ammo. No 50 BMG's on outdoor.
- 25 Indoor range is PISTOLS ONLY. NO pistol carbines, rifles or shotguns allowed. We reserve the right to ask to see your firearm.
- 26 What color is the employees shirt? You must tell the employee checking you in the answer in order to shoot.
- 27 **Damage to any part of the range due to neglect of the customer could result in customer paying for damages.**
- 28 **We are not responsible for lost or stolen property or any damages.**
- 29 **We reserve the right to change these rules and if we see anything being done unsafe to inform you. We reserve the right to ask you to leave or ban you from the range for unsafe shooting, use of alcohol or drugs.**

**WAIVER OF LIABILITY; INDEMNIFICATION AGREEMENT AND COVENENT NOT TO SUE NOTICE: This is a legally binding agreement. By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for injuries to yourself or your property arising out of your use of Red Rock Firearms, LLC now or anytime in the future.**

I acknowledge that I voluntarily have chosen to enter Red Rock Firearms, LLC. I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators, state that I understand that the activity that I have chosen to participate in (and/or observe), including without limitation any building, structure, parking areas, sidewalks and land, leased, occupied, used or accessed by at Red Rock Firearms LLC. (hereinafter "RRF") is very hazardous in that loaded firearms and weapons are discharged not only by myself but also other RRF members, guests and visiting public and that I could be seriously injured or even killed. I agree to read and abide by all the RRF Rules, Policies and Operating Guidelines, and I agree to assume any and all risks associated to and with the use of the facilities, including but not limited to: participation in RRF sponsored events, and the use and discharge of firearms, accidental discharge of firearms bodily injury or injuries, death or deaths, loss of personal property through misplacement, loss or theft, including any and all liability actions arising out of negligence on the part or RRF, it's agents, officers and/or members while at RRF.

I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators, for the consideration of being allowed to enter and use the facilities and services of RRF, and to observe the shooting competitions, and for other valuable considerations, do hereby absolutely and unequivocally agree to release, save and hold harmless RRF, the Officers and Directors and Members of RRF, its sponsors, agents, employees, instructors, assigns and successors in interest from any claim, demand or liability (whether claimed by myself or another person or entity) which may arise out of any loss, damage, injury or death which I may sustain, as well as any theft, unexplained disappearance or damage which may befall my property accompanying me (whether while en route to, during participation in or during observation of the event(s), and while en route from the event, or while on the RRF premises) where any of the match events occur, with the above use of facilities and services. I understand that this risk includes, but is not limited to, any lead dust inhalation, noise, airborne materials or objects, and the actions of other users of the RRF.

**I VOLUNTARILY ASSUME ALL SUCH RISKS IN CONNECTION WITH SAID ACCESS AND USE, WHETHER FORESEEN OR UNFORESEEN AND FURTHER, FOR MY FAMILY MEMBERS, GUESTS AND MYSELF (and heirs, agents, assign beneficiaries, executors and administrators).**

I, on behalf of myself and all family members, agree to indemnify and hold harmless RRF, the Officers and Directors and Members of RRF, its agents, employees, instructors, assigns and successors in interest for any and all damages caused by my use of the RRF property and discharge of firearms which would include, but not limited to, damages or personal injuries caused by my negligence and/or the negligence of minors or other persons that I have brought to RRF and attorney fees and costs to defend any and all claims brought against RRF, the Officers and Directors and Members of RRF, its agents, employees, instructors, assigns and successors in interest resulting from my use of the RRF or that of minors or other persons that I have brought to RRF.

I further acknowledge the right of RRF Officers or Ranger Officers to immediately terminate my participation in activities upon any failure of mine (or my guests) to fully comply with all RRF Rules, Policies and Operating Guidelines and directions of the Range Officer, I hereby state that I am under NO legal injunction that prohibits my owning, possessing, handling or using any of the firearms used in events at RRF.

By my signature below, I certify that I have read, understand and agree to the terms and conditions of this Release and Waiver and the RRF Rules Policies and Operating Guidelines. I also agree that I (and any minors and guests brought with me) will, at all times within the RRF Range Property wear appropriate eye and ear protection. It is intended that this Release and Waiver be valid for all visits to RRF upon my signature of this document for now and any time in the future.

I acknowledge that the foregoing agreement is intended to be as broad and inclusive as permitted by the law of the State of Oklahoma and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. I understand that the terms of this agreement are legally binding and that I am signing this agreement, after having carefully read it, of my own free will. I acknowledge that I am not a felon and am lawfully legal to have a firearm and/or ammunition in my possession.
